How to properly dismiss a lawsuit/judgement.

1.Gather the paperwork that you received from the lawsuit if you have any. That paperwork should have information on the court and corporation/Attorney suing you. Bring it with you so they can locate the case.

2.Go to the courthouse that's on the paperwork and File a (motion to Vacate or dismiss judgment). The clerk will tell you which form to fill out. Just say motion to vacate or dismiss. If you have letters demanding debt validation from (Debt collectors) bring it to attach to motion or if you have letters demanding original agreements from alleged original creditors bring it to attach to motion. Everything is pretty much a motion to do something when dealing with the courts from my experience.

3.Your reasons would be 1 of the following. I demand a motion to dismiss because:

I was not properly served a summons at my address.

I responded to the summons, but a judgment was issued anyway, without a hearing.

\*(The collection agency failed to respond to my request for Validation which resulted in insufficient validation: therefore, they failed to provide proof that the debt was my responsibility, under the Federal Debt Collection Protection Act (FDCPA) I demand This judgement be dismissed).

\*(The alleged original creditor didn't provide me with a copy of the original agreement allegedly between us, such as the promissory note or credit card agreement allegedly signed by me).

4.Attach Sample Letter for MOTION AND DECLARATION TO VACATE/DISMISS JUDGMENT
